

Terms and Conditions ("Terms")

Please read these terms and conditions carefully before using Our Service.

1. Interpretation and Definitions

Interpretation

The words of which the initial letter is capitalized have meanings defined under the following conditions.

Definitions

The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

- "Account" means an account created for You to access our Service or parts of our Service.
- "Affiliate" means an entity that controls, is controlled by or is under common control
 with a party, where "control" means ownership of 50% or more of the shares, equity
 interest or other securities entitled to vote for the election of directors or other
